Choice of Language and Means of Receiving Corporate Communications

China Mobile Limited (the "**Company**") is making arrangements for you to choose to receive Corporate Communications^(Note)

- (i) in **electronic form** on the Company's website at www.chinamobileltd.com or in **printed form**; and
- (ii) if you choose to receive Corporate Communications in printed form, to choose to receive them in **English, Chinese** or both.

If the Company does not receive your response by **3 April 2011**, you are deemed to have agreed to receive the Company's Corporate Communications through the Company's website.

Pursuant to the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "**Listing Rules**"), the articles of association of the Company and the Companies (Amendment) Ordinance 2010, the Company is permitted to make available the following options for you to choose for receipt of future Corporate Communications:

- (1) to read the website version of all future Corporate Communications published on the Company's website at www.chinamobileltd.com in place of receiving printed copies; or
- (2) to receive the printed English version of all future Corporate Communications only; or
- (3) to receive the printed Chinese version of all future Corporate Communications only; or
- (4) to receive both the printed English and Chinese versions of all future Corporate Communications.

In support of environmental protection and for the purpose of saving printing and mailing costs, the Company recommends you to select option (1) above. To make your choice, please complete the enclosed reply form and sign and return it to the Company's share registrar, Hong Kong Registrars Limited, using the provided prepaid mailing label.

If the Company does not receive a duly completed and signed reply form from you or receives no response from you indicating that you object to receiving Corporate Communications in electronic form on the Company's website on or before 3 April 2011, you are deemed, until you inform the Company otherwise by reasonable notice in writing (see below for details), to have consented to receive our Corporate Communications in the manner as set out in option (1) above. In that event, when the Company makes a Corporate Communication, we will send you a notification that the Corporate Communication has been made available on the Company's website. The notification will be sent by post to you at your address as it appears in the Company's register of members maintained by the Company's share registrar.

You may change your choice of language and means of receipt, free of charge, at any time by reasonable notice in writing to the Company at the Company's office at 60/F, The Center, 99 Queen's Road Central, Hong Kong or to the Company's share registrar, Hong Kong Registrars Limited at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong or by sending email to ChinaMobile.ecom@computershare.com.hk, notwithstanding any wish to the contrary you have previously conveyed to the Company or the Company's share registrar. Even if you have chosen (or are deemed to have consented) to receive all future Corporate Communications by electronic means but for any reason have difficulty in receiving or gaining access to the Corporate Communications, the Company will promptly upon your written request send the Corporate Communications to you in printed form free of charge.

Please note that printed copies of the English and Chinese versions of all future Corporate Communications will be available from the Company and the Company's share registrar on request. They will also be available on the Company's website at www.chinamobileltd.com and on the HKExnews website of Hong Kong Exchanges and Clearing Limited at www.hkexnews.hk.
